Article 45 of Directive 2004/18/EC on the coordination of procedures for the award of public works contracts, public supply contracts and public service contracts, read in conjunction with Article 2 of the directive, and the principle of equal treatment and the obligation of transparency must be interpreted as not precluding the exclusion of an economic operator from a procurement procedure on the grounds that the operator has failed to comply with the requirement laid down in the contract ...

Public procurement - EU Case Law

2.1 EU public procurement law is based upon certain general principles derived from the Treaty on the Functioning of the European Union ("TFEU") [see Endnote 3], and is aimed at ensuring equal access for all operators within the EU internal market to procurement opportunities in other EU Member States, as well as fair competition for public contracts.

Nonetheless, the case-law of the Court has interpreted that this does not preclude the option for Member States to maintain or establish, in addition to those grounds for exclusion, substantive rules intended, in particular, to ensure, with regard to public procurement, observance of the principles of equal treatment of all tenderers and of transparency, which constitute the basis of the EU directives on public procurement procedures, provided that the principle of proportionality is observed.

For example, where the public authority recognises that pursuing the procurement would mean awarding a contract that was not the most economically advantageous, or would not be expedient in the public interest; or it becomes apparent that continuing with the process means that the authority will act in such a way as enables a private or public law claim to be brought against it.
