General inpatient care (GIP) is available to all hospice beneficiaries who are in need of pain control or symptom management that cannot be provided in any other setting. Skilled nursing care may be needed by a patient whose home support has broken down if this breakdown makes it no longer feasible to furnish needed care in the home setting.

General Inpatient (GIP) Care is one of the four levels of care available to patients who elect the Medicare Hospice Benefit. GIP level of care is appropriate when the patient's medical condition warrants a short-term inpatient stay for pain control or acute or chronic symptom management that cannot feasibly be provided in other settings.

You're admitted to the hospital as an inpatient after an official doctor's order, which says you need inpatient hospital care to treat your illness or injury. The hospital accepts Medicare. In certain cases, the Utilization Review Committee of the hospital approves your stay while you're in the hospital.

Medicare Hospice: Use of General Inpatient Care (OEI-02-10-00490) brief periods of crisis in which a beneficiary requires continuous care to achieve palliation or management of acute medical symptoms. Inpatient respite care is short-term inpatient care provided to the beneficiary when necessary to relieve the beneficiary's caregiver(s).

A general inpatient care day is a day on which an individual who has elected hospice care receives general inpatient care in an inpatient facility for pain control or acute or chronic symptom management which cannot be managed in other settings. 418. 302(e)(5) The inpatient rate is paid for the date of admission and all subsequent inpatient days, except the day on which the patient is discharged.

Hospice general inpatient care (GIP) is for pain control or symptom management provided in an inpatient facility that cannot be managed in other settings.
